Old Business: Vote passed to accept the settlement from Sultan school district. Vote passed to accept Karnak to fix bridge rails and to grind and resurface bridge deck. Play chips for lower park.

Secretary: Three of the small claims proof of service were rejected. The judge requested a process service be used and rescheduled court date to June 28th. I contacted a process service company from Everett with a 5* rating. They work in all counties. Since we are an HOA they will bill us for the service.

MSA to contract the process service company for 3 small claims. Fees of \$95 each for 2 Goldbar and \$75 for Dupont (\$265) total to continue the small claim court filing. One claim was paid in full by owner and was dismissed in court.

I contacted Topsoils NW for a bid to deliver play chips for lower park. Estimate for 5 yards and delivery fee, taxes included is \$550.96. Tabled until the upper park play set is installed and both parks will get play chips.

I found two small playsets that we may want to consider for upper park. Reasonably priced and will fit in the space that was prepared. The playsets are for 2 to 12 year olds.

MSA to purchase a play set for upper park. Patriot Point cost \$5,599, installation \$2,850, taxes \$768.96 (freight discount \$2,250) totaling \$9,217.96. A deposit of 50% required to start the process. With installation 3 to 4 weeks out.

By-Laws Executive Committee:

The change to by laws voted on will be presented to the next community meeting for review, if possible with an Attorney review of proposed changes. Austin to continue to search for an attorney to review our proposed by laws to meet Washington State requirements

Finance:

Roads: Sultan school bus drivers are complaining that Ajer and Larson Drive intersection and Nelson and Goldbar Blvd impedes clear line of site. Unsafe for drivers and children. I contacted owner on Ajer and Larson Drive and they will do a cut back on corner to create better visibility

Parks: The upper park needs a swing added to the 2 seat swing set frame. The chain is still there, just need someone to install a seat.

Violations: No violations

Open Forum/New Business: I page domain name renewal paid \$21.99. Austin said we have other options to take domain name to a different web page.
