Our fiscal year tax return is due October 15th and that is why I filed for an extension and IRS accepted it. I completed the annual report with Washington Secretary of State.

I spoke with Brian Sullivan the Snoho County Assessor regarding joined lots. The county and owner can determine to join lots as one to lower taxes or because the size of lots. The assessor pointed out to me that the HOA bases their dues for expenses on the amount of lots sold in total. The By-Laws are written in just this way stating

Article XI Fees and Assessments

"For the purpose of financing the activities of the corporation, it is hereby declared that all lots within the jurisdiction of the corporation shall be charged and or assessed fees."
